

# Regulations on Support for Students with Disabilities

Established March 1, 2017

**Article 1 (Purpose)** These regulations establish operational matters regarding support for students with disabilities pursuant to Article 57-2 of Statutes of Pohang University of Science and Technology (hereinafter referred to as the “University”).

**Article 2 (Definition)** The term “disabled student” shall mean a student enrolled at the University and registered as a person with disability under the Act on Welfare of Persons with Disabilities.

**Article 3 (Scope of Application)** These regulations shall apply to students with disabilities studying at the University.

**Article 4 (Range of Support)** The University may provide support for students with disabilities regarding the following matters:

1. Matters related to teaching and learning of students with disabilities
2. Matters related to disabled students' living conditions and welfare
3. Matters related to facilities and equipment for students with disabilities
4. Matters related to general and career counseling for students with disabilities
5. Matters related to plans on improving and developing supports for students with disabilities
6. All other matters related to students with disabilities

**Article 5 (Center for Students with Disabilities)** ① The University shall establish and operate the Center for Students with Disabilities (hereinafter referred to as the Center) under the Office of Admissions and Student Affairs to be in charge of overall matters related to supporting students with disabilities.

② The purpose of the Center shall be to perform the duties stated in Article 4.

③ The Vice President of Admissions and Student Affairs shall be the head of the Center, and the Center may have dedicated staff to facilitate the performance of its duties.

**Article 6 (Committee on Students with Disabilities)** There shall be a Committee on Students with Disabilities (hereinafter referred to as the “Committee”) to review major issues of the Center.

**Article 7 (Organization)** ① Members of the Student Affairs Committee shall be ex officio members.

② The Chairperson shall be the Vice President of Admissions and Student Affairs.

③ The Committee shall have a secretary, and the secretary shall be the Director of Student Affairs.

**Article 8 (Functions)** The Committee shall review the following items:

1. Matters related to the management of the Center
2. Matters related to request for examination by students with disabilities
3. Matters related to amending regulations regarding students with disabilities
4. Matters related to planning support for students with disabilities
5. Other matters necessary for reviewing and making decisions related to students with disabilities

**Article 9 (Request for Examination)** ① Students with disabilities and their guardians may make written requests for support needed for studying and/or university life to the Center.

② The Center must request the Committee to perform a review and make a decision on request for examination.

③ The Committee must notify the results of the review and the decision to the applicant.

**Article 10 (Miscellaneous matters regarding the Committee)** Matters related to the operation of the Committee not stipulated in these regulations shall be determined by the President of the University after a review by the Committee.
