# SIMULTANEOUS ENROLMENT IN TWO DEGREE PROGRAMMES

## Requirements and procedures

In the following table you can find a summary of the available procedures to access a degree programme; each entry is clickable and linked to the relevant page. The instructions in this document are referred to **procedures highlighted in green**.

## Conditions and compatibility for simultaneous enrolment

### Two bachelor's degree programs, Single-cycle or Master's degree

In accordance with the *Guidelines of the University of Padua for simultaneous enrolment*, simultaneous enrolment in **two Bachelor's, Single-cycle or a Master's** degree programmes is compatible under the following conditions:

**Degree class** (classe di laurea): the two degree programmes must belong to different degree or master's degree classes, granting two different qualifications at the end of each career.

**Educational activities:** the two degree programmes must differ in at least two-thirds of the exams/activities, with regard to the SSDs/SADs and CFUs/CFAs (ECTS) attributed to the compulsory core, basic, related or supplementary course units. In the case of degree programmes of different durations (e.g., a Bachelor's and a Single-cycle degree programme) the calculation of two-thirds is made on the shorter degree programme.

**Student fees:** in order to enrol in a second degree programme, it is necessary to be up to date with the payments of the first degree programme.

**Compulsory attendance:** for the purposes of simultaneous enrolment, "degree programme with compulsory attendance" means a degree programme in which attendance at all the planned lessons is compulsory, excluding laboratories and internships, as indicated in Annex 2 of the relevant Teaching Regulations (regolamento didattico) of the degree programme. As for the degree programmes of the University of Padua, those with compulsory attendance are listed here:

Simultaneous registrations are allowed for the following combinations:

- Two degree programmes without compulsory attendance;
- One degree programme with compulsory attendance and one without compulsory attendance;
- Two degree programmes with compulsory attendance, provided that part-time enrolment has been activated for one of the two degree programmes, and that the student joins said part-time enrolment<sup>2</sup>.

The **compatibility assessment** of simultaneous enrolment is carried out:

- for simultaneous enrolment in two degree programmes at the University of Padua: between the submission of the application for enrolment and the finalization of the same;
- for simultaneous enrolment between a degree programme at the University of Padua and at another university: within the beginning of the first exam period as per the Academic Calendar.

In the event of incompatibility between the two degree programmes, the student will be contacted for the closure of one of the two careers.

### **Other situations**

- the same conditions set out in this document apply to those who are simultaneously enrolled in a foreign university, except for the calculation of the 2/3 of the SSD credits differentiation;
- the Double degree (DD) path is not compatible with simultaneous enrolment;
- the Joint degree (JD) path is compatible with simultaneous enrolment.
- International mobility is managed as follows:
  - o It is possible to undertake mobility with a scholarship only in the degree programme selected to access the financial benefits provided by current legislation on the right to education;
  - o Training activities undertaken outside of the Learning Agreement, subject to availability from the partner institution, may be recognized in the other career path following submission of the transcript of records and related programs to the credit recognition commission.

### **A bachelor's degree, single-cycle or master's degree programme and another type of programmes**

In accordance with the Guidelines of the University of Padua for simultaneous enrolment, simultaneous enrolment in a Bachelor's, Single-cycle or Master's<sup>3</sup> degree programme and in another type of degree programme (Master I, Master II<sup>4</sup>, Specialisation school, PhD, Postgraduate

programmes, single course) is always compatible, with the sole exception of Medical Specialisation schools.

### Procedures for simultaneous enrolment

In this paragraph, the following terminology will be used to refer to the type of degree programmes:

- **group 1:** Bachelor's, Single-cycle and Master's degree programmes
- **group 2:** Master I and Master II (as per the Italian meaning), Specialization school (excluding Medical Specialization schools), PhD, Postgraduate programmes, AFAM institutions

The procedures are different depending on the type of degree programme and the University where the degree programmes are taken. The possible cases are shown in the following table:

Below are the procedures to be followed for each case.

#### Case B

The enrolment application in the degree programme provided by the University of Padua must be submitted following the standard procedures as per the Call for admission ([www.unipd.it/avvisi-ammissione-corsi](http://www.unipd.it/avvisi-ammissione-corsi)), without any difference from those who do not request the simultaneous enrolment.

After obtaining the student number (matricola), it is necessary to fill in the declaration of simultaneous enrolment by accessing the Uniweb portal, selecting the items "Home" > "Dichiarazione aggiuntiva".

The enrolment application in the degree programme provided by the other university/institution and the simultaneous enrolment declaration must be submitted following the procedures provided by that University.

The procedure does not vary even if the enrolment in the two degree programmes has taken place in two different academic years. It is also not relevant whether the first enrolment has been finalized in the University of Padua or in the other University.

### **Case C**

The enrolment application must be submitted following the standard procedures as per the Call for admission for degree programmes in group 1 ([www.unipd.it/avvisi-ammissione-corsi](http://www.unipd.it/avvisi-ammissione-corsi)) and as per the procedures for programmes in group 2 ([www.unipd.it/post-lauream](http://www.unipd.it/post-lauream)), without any difference from those who do not request the simultaneous enrolment.

After obtaining the student number (matricola), it is necessary to fill in the declaration of simultaneous enrolment by accessing the Uniweb portal, selecting the items "Home" > "Dichiarazione aggiuntiva". The declaration must be submitted twice by accessing both careers, and indicating for each degree programme the simultaneous enrolment with the other.

The procedure does not vary even if the enrolment in the two degree programmes has taken place in two different academic years.

### **Case D**

The enrolment application in the degree programme provided by the University of Padua must be submitted following the standard procedures as per the Call for admission ([www.unipd.it/avvisi-ammissione-corsi](http://www.unipd.it/avvisi-ammissione-corsi)), without any difference from those who do not request the simultaneous enrolment.

After obtaining the student number (matricola), it is necessary to fill in the declaration of simultaneous enrolment by accessing the Uniweb portal, selecting the items "Home" > "Dichiarazione aggiuntiva". The enrolment application in the degree programme provided by the other university/institution and the simultaneous enrolment declaration must be submitted following the procedures provided by that University.

The procedure does not vary even if the enrolment in the two degree programmes has taken place in two different academic years. It is also not relevant whether the first enrolment has been finalized in the University of Padua or in the other University.
